Meeting called to order at 7:00 PM at Sandy Flaming's House		
1) Minutes from June 18 <sup>th</sup> meeting were reviewed. Sandy moved to accept, Linda seconded.		
2) Chantal gave us the new numbers for the teams. Bunny 21 registered with 5 missing. Novice 22 registered 2 missing Petite 16 registered 5 missing Tween 22 registered 6 missing Junior 17 registered, still waiting for registration forms from Kelsey, Kennedy Wilson and Meagan. Presley is withdrawing as she is attending school in BC for the next year. That should leave a total of 19 when all registration forms are received. Some of the registered girls will potentially be trying out for AA teams. Belle 17 registered none missing. Open 6 registered with 13 missing. (potential 9 possible)		
3) Donna Smith advised that our fee structure as it is, is workable and that we have approximately \$5000.00 to play with.		
4) Belle level: there is a request for one belle player to move up and one to remain at the junior level. Linda has spoken to the mother of the player who wants to move up to open and it appears she understands everything involved and she is okay with it. There was a decision made to allow the one belle player to move up and one to move down to junior. These decisions were based on the numbers. The belle player requesting to play open will have to pay the open fees. Linda advised that the belle players would like to be included in the player development sessions with Lori Horne. We will need to have two goalies in order for this to work at the junior level. We will need to contact Linda Snyder and advise her as to the teams at the junior and belle level. She will need to schedule the ice using the scenarios of one junior team and one belle team, as well as two junior teams and one belle team. She would have to use the ABC scenario that we used a couple of years ago. Ex. One week each junior team would have two practice times, and then the next week, they would have one practice and one dryland. This would alternate.</p> <p>Linda Murtha advised that using the presented ice schedule, that the belle and junior levels have more weeknight than weekend practice time.</p>
